MANDATED REPORTING

NORTH CAROLINA

WHY SHOULD I MAKE A REPORT?

- Ensure Child Safety: Instead of wondering, "What if I'm wrong?", ask yourself, "What if I'm right?". Your intervention could prevent or stop ongoing abuse.
- Provide Essential Support: Help families access the assistance they need, which they might not receive otherwise.
- Fulfill Our Responsibility: As adults, it's our duty to prevent abuse and protect children in our society.

WHAT INFORMATION IS NEEDED WHEN MAKING A REPORT?

- The name, age, and address of the child.
- The name and address of the child's parent or caregiver.
- The child's condition, including the nature and extent of the injury or abuse.
- Any information regarding the presence of weapons, alcohol/drug abuse, or other factors affecting safety.
- Where the child is located at the time the referral is made.
- IF YOU ARE MISSING ANY OF THIS INFORMATION, MAKE THE REPORT ANYWAY.

CAN I MAKE AN ANONYMOUS REPORT?

Yes! However, providing your name and contact information helps investigators follow up if needed. DSS keeps your identity strictly confidential, only releasing it to government entities with a court order.

WHAT ELSE SHOULD I KNOW?

- You do NOT need proof of abuse, only reasonable suspicion, to make a referral.
- You do NOT need permission from parents or caregivers, nor do you need to inform them of the referral.
- You do NOT need permission from your workplace to make a referral.
- You do NOT need to worry about liability if your referral is made in good faith, as you are protected from civil or criminal repercussions.

WHAT IS MANDATED REPORTING?

Mandated reporters are people required by law to report suspected or known instances of abuse.

WHO IS A MANDATED REPORTER IN NC?

NC Law requires ANY person 18 years of age or older who knows or has cause to suspect that a child is being abused or neglected, or has died as a result of maltreatment, to report their concerns to the Department of Social Services or local law enforcement (G.S. 7B-301).

WHAT IF I DO NOT REPORT?

Any person or institution who knowingly fails to report or prevents another person from making a report as required by law is guilty of a Class 1 misdemeanor (G.S. 14-318.6).

REMEMBER:

If YOU see, suspect, or are told something,

YOU are required to say something.
